NOTE When mounting the lock the installation instruction has to be followed.

The outer dimensions, bolts and security relevant points of the 2608, 2618, 2628 and 2648 types of the 2600 series differ from each other. Therefore, every type must be assessed and added separately during integration into the lock list of the secure storage unit concerned.

The usage of the high security locks of the 2600 series for direct locking shall be proven separately.

The type N-2618 is not additionally mentioned, it can be used as emergency lock for other Carl Wittkopp locks and is therefore part of the electronic lock certification, for instance PRIMOR 3010.

The marking as ECB•S certified product, in compliance with this certificate, is only allowed with an original ECB•S certification mark as proof of conformity according to ISO/IEC 17065.
